

By Purchasing or receiving a Pass, Holder (defined below) agrees, on behalf of Holder and any accompanying minor, including a minor holding a separate Pass or otherwise, to the following terms and conditions (herein after referred to as these “**Terms**”). Except where explicitly stated, these Terms shall apply to all Passes. These terms may be amended from time to time without notice, and shall be binding on Holder. By entering the Venue and/or using a Pass, Holder is indicating that Holder understands these Terms. These Terms include and incorporate the terms of use, available at [Front Gate](#), provided that these Terms shall govern over any conflicting terms in such policies. See below for Honeyland Week Terms and Conditions.

PLEASE READ THE FOLLOWING TERMS CAREFULLY AS THEY GOVERN YOUR RIGHTS UNDER A PASS.

DEFINITIONS

“**Accredited Organization**” the accredited organization to which a Credential Holder belongs to.

“**Credential**” means a type of Pass (including a Media Credential defined herein) for entry into certain restricted areas or Festival as determined by Organizer.

“**Holder**” means the holder of a Pass and any accompanying minor, including a minor holding a separate Pass.

“**Organizer**” means the “**IMG Worldwide, LLC**”

“**Pass**” – means a Ticket, a Credential (of any kind) and/or any other item that grants entry into the Festival.

“**Festival**” means the 2023 Honeyland Festival

“**Festival Parties**” means Organizer, LNU and Venue.

“**Ticket**” means a type of pass (general admission (GA), GA+, VIP, or Platinum for entry into the Festival premises for a spectator seat for the applicable Festival.

“**Venue**” Crown Festival Park at Sugar Land

1. **License.** Each Pass is a nontransferable revocable license to be used as indicated. **ALL TICKET SALES ARE FINAL. NO REFUND OR EXCHANGES EXCEPT AS EXPLICITLY PORVIDED HEREIN.**
2. **Credentials.** Credentials are to be used in the exact manner as prescribed by Organizer in its sole discretion. Credential Holders agree to (i) refrain from taking photographs, audio recordings, and video footage of any kind in restricted areas, including but not limited to all back of house areas, trailers, offices, BOH kitchens, storage space, (the taking of photographs, audio recordings, and video footage applies to the use of all equipment having the capability of capturing such images, including but not limited to mobile phones); (ii) refrain from requesting artist and talent autographs at any time during the Festival, with the exception of scheduled autograph sessions; (iv) refrain from bringing any non-credentialed persons into any restricted areas, and (v) abide by any lawful direction given to Holder by Organizer or Festival officials during the Festival. No Holder or Accredited Organization, other than Festival classified media, photographer, television, or similarly categorized credential (“**Media Credential**”), are permitted to collect or record any film (professionally), audio, video or digital video of any of the Festival (“**Recorded Material**”) without express advance written permission from Organizer. Holder and Accredited Organization may request video footage from Organizer for use in connection with a legitimate, regularly scheduled television news or sports news telecast. Use of Recorded Material for any other purpose (including but not limited to display and/or transmission via the Internet) without the advance written permission of Organizer is expressly prohibited.

A Media Credential authorizes the Accredited Organization to use, exclusively for news and editorial coverage of the Festival, any descriptions (including statistical descriptions), accounts, photographs or drawings of the Festival (other than film, video and digital video, which are addressed below) taken, made, created, or compiled by the Accredited Organization, in accordance with these Terms and any other regulations or restrictions imposed by Festival parties and/or their respective officials. Any other use or attempted use by Holder of a Media Credential or the **Accredited Organization** of the Works (defined below) or Recorded Material, including any distribution of such Works or Recorded Material to third parties other than ultimate consumers (such as newspaper readers) for their use whether before, during or after the conclusion of the

Festival, and whether or not for editorial purposes, and any authorization of any third party to redistribute the Works or Recorded Material, is expressly prohibited, unless the Holder and Accredited Organization has obtained, in advance, the express written consent of the Festival for such use. These terms and conditions shall apply to all Holders.

- 3. Postponement/Cancellation/Changes.** If the entire Festival is cancelled, and Holder purchased a Pass through the “**Official Festival Ticket Channel**” (defined as Front Gate Tickets, Festival will issue a refund of face value paid for the Pass (if any)(or, for a discounted ticket, the discounted ticket price paid) to the credit card, debit card, or other accepted method of payment that Holder used to purchase the Pass. The foregoing is subject to applicable law and is limited to Passes purchased directly through the Official Festival Ticket Channel, and does not apply to Passes (i) purchased via the secondary market, (ii) provided on a complimentary or barter basis, (iii) issued in connection with any sponsorship. If tickets were purchased through another method, please contact the person or entity from whom such tickets were purchased, as Festival will not issue a refund directly to Holder therefor. In no event will delivery charges or any other amounts be refunded. There will be no liability on the part of any of the Festival Parties for travel or any other expenses that Holder or anyone else incurs in connection with a canceled Festival.

Festival capacity may be adjusted upward or downward without notice. Festival dates and times (including the opening of the gates and artist set times) are subject to change without notice by the Festival Parties in their sole discretion. Festival schedules (including schedule of artist performances) are subject to change by the Festival Parties in their sole discretion; no change shall entitle Holder to a refund/remedy if Holder cannot attend or for any other reason. Furthermore, no refunds will be provided for artist(s) cancellation or replacement.

- 4. Prohibited Items.** In addition to those items prohibited elsewhere in these Terms, without the express prior written permission of Organizer, Holder may not bring any of the following items into the Festival (or cause any of items to enter the Festival): glass bottles, aluminum bottles, knives, explosives, sling shots, guns of any kind, weapons of any other kind, frisbees, balloons, balls, inflatable balls, umbrellas, chairs, stools, or other seating devices, flags, motorized scooters, bicycles, skateboards, roller skates, hover boards, laser pointers, drones of any kind, remote controlled devices or remote controlled toys, large backpacks, illegal substance of any kind per local, state and federal laws, professional recording equipment, and other items as designated by Organizer. Festival Parties reserves the right to refuse admission to or eject any person, at Festival producer's sole discretion, whose conduct is disorderly, disruptive, or who fails to follow the Festival’s rules or directions, or whose language is vulgar or abusive.
- 5. Bag Policy.** Only small bags (4.5 x 6.5) and single compartment purses (max 12” x 12”) allowed. Large bags will not be permitted into the Venue. Please do not bring suitcases, bicycles, scooters or any large items bigger than a handbag or backpack.
- 6. Compliance.** Holder must comply with all Festival Parties policies, including security, fan conduct, health and bag policies and these Terms. Upon entrance Holder and Holder’s belongings may be searched. may be confiscated. Festival Parties retains the right, in their sole discretion, to prohibit entry onto the Venue of any items (whether or not specified on the prohibited items list) it deems inappropriate or dangerous. Holder consents to searches and waives any claims relating thereto. If Holder does not consent to such searches, Holder acknowledges the Festival Parties have the right to deny admission or eject Holder without refund. The Festival Parties reserve the right to deny or revoke admission of any person who the Festival Parties, in their sole discretion, determine pose a risk to health/safety or whose conduct violates these Terms, any Festival Parties policies, or is otherwise disorderly (or complicit therein) without refund.

7. **Intellectual Property/Use of Image and Likeness.** Holder agrees not to create, transmit, display, distribute, exploit, misappropriate or sell (or aid in the same) (1) in any form, any description/account of the Festival or related events (“**Data**”) for commercial/non-personal purpose; (2) any images, videos, audio or other form of display or public performance or reproduction of any portion of the Festival (“**Works**”) for any commercial/non-personal purpose; or (3) livestreams (on a live or delayed basis, in whole or in part, whether on a free basis or subject to payment) of any portion of the Festival (“**Streams**”).

Notwithstanding the foregoing, Holder agrees that by causing its ticket to be scanned upon entry, Holder shall be deemed to have signed the ticket and granted to the Festival Parties an exclusive worldwide, irrevocable, perpetual, sub-licensable, royalty-free license to all rights associated with the Works, the Streams, and the Data. Holder also grants irrevocable permission to the Festival Parties and their respective sponsors, licensees, advertisers, broadcasters, designees, and agents to use, publish, distribute and/or alter Holder’s image, likeness, voice, actions and statements in any medium including audio, video, or images of the Festival for any purpose without further authorization or compensation, and waives all claims relating to such use unless prohibited by law. Furthermore Holder, consents that the Festival Parties are permitted to collect, hold, store, process, modify, transfer, or delete certain personal (and sensitive) data in any medium about Holder for marketing purposes and the Festival Parties may disclose such information to its third party partners for such purposes.

8. **Unauthorized Use of Passes.** All publicly sold Tickets are for use by the original authorized purchaser and their invited guest(s) only (each an "**Authorized Purchaser**"), and are not transferable by the Authorized Purchaser, any of their invited guests, or any other person. Likewise, all Tickets provided to performing artists, production personnel, vendors, sponsors, and other guests of the Organizer (each an "**Authorized Recipient**"), are for use by the Authorized Recipient and his or her invited guest(s) only, and are not transferable by the Authorized Recipient, his or her invited guest(s), or any other person. For clarity, Authorized Purchasers and Authorized Recipients are also considered a "Holder" individually. Tickets obtained from unauthorized sources may be counterfeit and are worthless. Resale or attempted resale of Tickets is grounds for termination of the license and cancellation of the Ticket. The resale or attempted resale of a Ticket on or around the Festival/Venue at any price is prohibited and will result in Holder’s removal from the Festival/Venue and confiscation of all tickets in the possession of the violator without refund or compensation. The use or attempted use of lost, stolen or counterfeit tickets is prohibited and such tickets are void. The Festival Parties are not responsible for lost, stolen, destroyed, or counterfeit tickets. Lost, stolen, destroyed or counterfeit tickets, or tickets sold in violation of any applicable law, may not be honored. A Ticket may not be used for, nor may any Holder enter the Festival and/or Venue for, advertising, promotion or any other commercial purposes (including contests, sweepstakes and giveaways) without the Festival Parties’ express written consent. The first ticket with a barcode or RFID presented to be scanned will be considered valid and all others will be rejected and entry denied to its holder. No sponsorship, on site marketing, sampling, vending, coupon/product distribution, or other promotional activity may be conducted at the Festival (inclusive of parking lots), absent the Festival producer's prior written approval in each instance. Any Tickets used in violation of this provision shall be deemed revoked and void, and their bearers deemed trespassers at the Festival.
9. **Medical Consent.** Holder consents to have medical treatment that may be deemed advisable in the event of an injury, accident, or illness during the Festival and affirmatively releases the Festival producer and all persons participating in such medical treatment from all responsibility for any such actions.
10. Breach of any of these Terms, failure to comply with safety requirements, rules or policies of Festival or Venue, shall automatically terminate any rights that Holder may have hereunder; shall render illegal and unauthorized your use of the ticket for any purpose (including but not limited to any misconduct, illegal activity, intoxication, use of illegal substance, breaches of etiquette, disruptive behavior, or heckling); and shall

authorize Festival and/or Venue to withdraw the ticket, refuse admission to the Festival, or eject you from the Festival and confiscation of all tickets in the possession of the violator without refund or compensation, without refund or credit in each case, and subject you to all legal remedies available to the Festival and/or Venue. This Ticket may be revoked without refund/other consideration if holder: (a) tampers with or attempts to transfer/re-sell/repackage this Ticket; (b) violates any Festival rules/ regulations, Venue security restrictions, or the instructions of authorized personnel; (c) solicits contributions or distributes literature/promotions on or around the Venue without prior written permission from Festival; (d) uses foul/abusive language or obscene gestures, or otherwise engages in inappropriate, disruptive, or illegal behavior; as determined by Organizer; or (e) as otherwise determined by Organizer in its sole discretion.

- 11. Assumption of Risk.** Holder voluntarily assumes all risks, hazards, and dangers incident to the Festival and related events, including the risk of lost, stolen or damaged property or personal injury of any kind (including death), risk of exposure to communicable diseases, viruses, bacteria or illnesses or the causes thereof, sickness, and all hazards arising from, or related in any way to the Festival however caused and whether by negligence or otherwise, and hereby waives any and all claims or potential claims arising from such risks, damage or injuries. AN INHERENT RISK OF EXPOSURE TO COVID-19 EXISTS IN ANY PLACE WHERE PEOPLE ARE PRESENT. COVID-19 IS AN EXTREMELY CONTAGIOUS DISEASE THAT CAN LEAD TO SEVERE ILLNESS AND DEATH. ACCORDING TO THE CDC, SENIOR CITIZENS AND THOSE WITH UNDERLYING MEDICAL CONDITIONS ARE ESPECIALLY VULNERABLE. BY ENTERING FESTIVAL PREMISES, HOLDER VOLUNTARILY ASSUMES ALL RISKS RELATED TO EXPOSURE TO COVID-19. Holder agrees that the Festival Parties and each of their parents, subsidiaries, affiliates, employees, agents and owners shall not be liable for any injuries, damages, claims or losses from any such causes.
- 12. Release.** On behalf of Holder and Holder's spouse, domestic partner, children, parents, grandparents, and, if the Holder is an entity, such entity's officers, directors, employees, service providers and subsidiaries, and in any case, whether an individual or an entity, each of the foregoing's estate, heirs, assigns, executors, administrators and affiliates (the Holder collectively with the foregoing, the "**Releasing Parties**") , Holder releases and covenants not to sue each of the Festival Parties or any of their respective parents, subsidiary entities, affiliates, sponsors, successors and assigns or each other person or entity who attends, participates in or provides services in connection with the Activities, and the respective directors, officers, members, managers, employees, agents, service providers, sponsors, business partners, contractors, partners, equityholders and representatives, in their individual, personal and representative capacities for each of the foregoing entities, and each of the foregoing's estate, heirs, assigns, executors, administrators and affiliates (collectively, the "**Released Parties**") with respect to any and all claims that the Releasing Parties may have (or hereafter accrue) against any of the Released Parties that relate to any of the risks, hazards and dangers described above, including any and all claims that arise out of or relate in any way to (i) Holder's exposure to COVID-19; (ii) Holder's entry into, or presence within or around, the Festival (including all risks related thereto, and including without limitation in parking areas or entry gates) or compliance with any protocols applicable to the Festival; or (iii) any interaction between Holder and Released Parties personnel present at Festivals, in each case whether caused by any action, inaction or negligence of any Released Party or otherwise. Holder hereby waives and relinquishes on behalf of itself and the Releasing Parties any and all rights and benefits to which such Releasing Parties may have under any statute or common law principle of any jurisdiction which provides, generally, that a general release does not extend to claims which a creditor does not know or suspect to exist in his or her favor at the time of executing the release, which if known by him or her must have materially affected his or her settlement with the debtor.
- 13. Indemnification.** Holder further agrees to indemnify and save and hold harmless the Released Parties from and against any/all liability they may incur due to holder's alleged acts or omissions thereof while present at or around the Festival.

IN NO EVENT SHALL THE FESTIVAL PARTIES BE LIABLE FOR SPECIAL, CONSEQUENTIAL, INCIDENTAL, INDIRECT OR EXEMPLARY DAMAGES OF ANY KIND.. ANY DISPUTE OR CLAIM IN ANY WAY RELATED TO THIS TICKET OR THE FESTIVAL SHALL BE RESOLVED BY MANDATORY, CONFIDENTIAL, FINAL, BINDING ARBITRATION BEFORE JAMS IN NEW YORK PURSUANT TO ITS STREAMLINED RULES EXCLUSIVELY ON AN INDIVIDUAL BASIS. HOLDER UNDERSTANDS THAT IT IS WAIVING ITS RIGHT TO A COURT OR JURY TRIAL AND ANY RIGHT TO ASSERT CLAIMS AS A CLASS ACTION, REPRESENTATIVE ACTION OR CLASS ARBITRATION. IF HOLDER DOES NOT CONSENT TO THIS, HOLDER MUST LEAVE OR NOT ENTER THE VENUE. THIS CLAUSE IS GOVERNED BY THE FEDERAL ARBITRATION ACT.

If any of these Terms should be determined to be illegal, invalid or otherwise unenforceable by reason of the law of any state or country in which these Terms are intended to be effective, then to the extent and within the jurisdiction in which that term or condition is illegal, invalid or unenforceable, it shall be severed and deleted from that term and the remaining Terms shall survive and continue to be binding and enforceable.

HONEYLAND WEEK TICKET ADD ON GIVEAWAY (“GIVEAWAY”)
